107-3 THE VIBE'S "POST MALONE AND JELLY ROLL" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries may be played on the air. On or about 9:00am CT on April 4, 2025, Station will select one (1) potential Grand Prize Winner (as defined below) in a random drawing from the four (4) Qualifying Prize Winners.
