1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Caller ten (10) to the Station, will give the station the name of the song and the artist of the song played backwards to be the Prize Winner as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. If caller ten (10) gives an incorrect song or artist, the next caller will be taken until the caller can give the song and artist correctly.
